ORAL REVIEW

Notice to Eligible Candidates

Wednesday, October 20, and Thursday, October 21, 2010

The Oral Review is open to those Intern Architects who have:

- completed and logged at least 2800 hours (preferably completed all of the required hours); and
completed the required AIBC courses.

Eligibility will be confirmed by the Registration and Licensing Department.

Oral Reviews assess your ability to practise the profession of architecture in British Columbia in accordance with local practice requirements. You must bring to the review a set of construction documents for at least one building more complex than a typical single-family residence and with which you have been involved. You may also wish to bring any other documents of either a design, technical or administrative nature that may help illustrate your involvement in the project. A letter from your employer advising in detail the extent of your participation with this project must be submitted to the AIBC along with your application form.

The application, the letter from your employer and the Oral Review fees, must be received by Monday, October 11, 2010. The Oral Review fee must be submitted at the time of application.

If you are unable to make it to your Oral Review we will issue you a refund so long as you notify us in writing on or before Wednesday, October 13, 2010. If you notify us after Wednesday, October 13, 2010 we will refund your fees less an administration fee of \$50 plus GST.

Oral Reviews are held at the AIBC at either 5:45 p.m. or 7:30 p.m. You will be notified by email of the date and time for your Oral Review once the schedule is complete (approximately a week or two prior to the session).
