## 2010 Call for Nominations: AIBC Special Certificate of Recognition

The AIBC Volunteer Recognition Committee welcomes nominations for the AIBC Special Certificate of Recognition. This award was established by the AIBC to recognize those individuals or firms who have made an exceptional contribution to the practice or the profession of architecture through volunteer activities.

### Criteria

The volunteer contribution should have been made over a minimum two- year period. Nominations must be made by an AIBC registrant, and should detail both the candidate's volunteer activities and the organizations with which they took place. These activities may have been made at the local, provincial or national level (only one award will be given per level), and should demonstrate expertise and leadership in specific initiatives that would aid, benefit or enhance the practice and profession of architecture.

### Eligibility & Nomination Process

Nominations are open to any AIBC registrant or firm. Eligible candidates must be nominated by two AIBC registrants in good standing, and nomination may be made with the support of an external professional group or representative with first-hand knowledge of the nominee's contribution. Submissions should outline the nominee's contribution in as much detail as possible within the criteria noted above. Each nomination is to be accompanied by a brief biographical profile, and must provide details of the nominee's qualifications as evidenced through response to the questions below.

The nomination form, including the original signatures of two nominators, must be submitted in writing (*neither e-mail nor facsimile will be accepted*) along with the nominators' phone, fax, and e-mail contact information. Nominations must be in the possession of the Director of Administration & Human Resources **no later than 4:30 p.m. on February 3, 2010**, at the Architectural Institute of British Columbia, #100-440 Cambie Street, Vancouver, BC, V6B 2N5.
