Michael A. Ernest AIBC Intern Architect Bursary

1.0 Introduction

Michael Ernest Retired Architect AIBC has been a part of the fabric of the AIBC and the British Columbia architectural community at large since the 1970s. He has filled numerous roles during his long-standing service to the profession: registered architect, principal, oral reviewer, committee member, councillor, council vice-president, registrar, adjunct professor, director of Professional Practice, Canadian Construction Documents Committee Chairman and AIBC Executive Director. Mike leaves a profound legacy through his thoughtful approach and collaborative style of leadership. Mike retired in December 2014. In recognition of his long-standing contribution to the profession, AIBC Council established the Michael A. Ernest AIBC Intern Architect Bursary. This bursary is available to an Intern Architect AIBC and is awarded annually.

2.0 Eligibility

The Michael A. Ernest Bursary is awarded based on the Intern Architect AIBC's demonstrated financial need and the intentions to become a registered Architect AIBC.

To be eligible for consideration for this bursary, applicants must demonstrate:

- Intern Architect AIBC registration in good standing;
- Limited financial resources; and
- An intention to become a registered Architect AIBC

The bursary, in the amount of \$1000, is in the form of a credit on the intern architect's account at the AIBC. The credited amount remains in place as long as the intern architect remains in good standing or until the amount has been applied. This credit can be applied against expenses paid to the AIBC (costs are as of January 2018), including:

3.0 Submission Process and Important Dates

Intern architects interested in applying for the bursary should complete the application form and submit it to the Director of Registration & Licensing on or before the deadline for submissions. All applications will be

considered on a strictly confidential basis. The Director of Registration & Licensing will review all applications and based on the facts submitted will recommend a bursary recipient to AIBC Council. The bursary recipient will be immediately notified upon council's decision. Unsuccessful applicants will be also notified shortly thereafter. The name or other information of the bursary recipient or other applicants will be kept confidential and not made public, except as may be required by Freedom of Information legislation.
