Why I am seeking a position on AIBC Council and, if elected, what I believe I can contribute to council and the Institute:

I am seeking re-election to the AIBC Council because I believe that I have the competencies, skills, and experience necessary to help ensure that the AIBC effectively regulates the profession of architecture in British Columbia in the public interest, while remaining a vibrant, active and effective organization now and into the future.

As a current member of the AIBC Council (2013-present) and the AIBC Vancouver Island Chapter Executive Team, I have consistently demonstrated my commitment and value to Council and the Institute by actively participating in Council meetings, forums and on numerous committees. My 25+ years of public sector work experience, private sector and national board experience enable me to contribute to the diversity of Council deliberations.

If re-elected I will continue to work hard to provide leadership in building public confidence and excellence in architectural practice. In addition, I will continue to seek ways to engage members, particularily those who live outside of the lower mainland; increase organizational transparency and efficiency; ensure effective oversight, risk and fiscal management; and, foster confidence within government and with stakeholders.

With significant membership support, I was elected to AIBC Council in 2013 for a two year term and re-elected for a second two year term in 2015. I am now seeking election for a third term.
