Note that the Continuing Education System (CES) requirements is not applicable to Retired Architects.
- 1.5 Cancellation of registration does not limit the AIBC's jurisdiction under [Part 6 of the Professional Governance Act - Protection of the Public Interest with Respect to Professional Governance and Conduct](#).
