Undertaking and Covenant by Architectural Technologist Applicants for Registration as Architectural Technologists AIBC

WHEREAS:

- A. On July 14, 2020, the AIBC Board, recognizing that the COVID-19 pandemic has interrupted the in-person offering of the Ethics, *Act* & Bylaws course since March 2020, approved the temporary relaxation of policy relating to completion of this mandatory course for Architectural Technologist (AT) applicants.
- B. The Ethics, *Act* & Bylaws course is one of the requirements Architectural Technologist applicants are required to complete to be eligible for registration as Architectural Technologists with the AIBC;
- C. Those applicants who are successful in their Architectural Technologist examination and who have completed all other registration requirements, may apply to register as Architectural Technologists AIBC, on condition that they execute this Undertaking and Covenant to the AIBC that they will complete the mandatory course within one year of being notified that course is being offered.

NOW THEREFORE:

- 1. I covenant and undertake to complete the mandatory course below, within one year of being notified by the AIBC that the course is being offered either in-person or through an online format.
 - Ethics, Act & Bylaws
- 2. I understand that I am not required to repeat the course above if I have already completed this course prior to the date of this Undertaking and Covenant.
- 3. I understand and acknowledge that if I fail to complete the mandatory course within the one-year period of being notified the course is available, this will result in a complaint being made to the AIBC Director of Professional Conduct and Illegal Practice. The Director of Registration and Licensing is authorized to provide a reasonable extension upon request by the undersigned, if they are unable to complete the mandatory course by the prescribed timeline due to restrictions imposed by the pandemic. Such requests are made on a case-by-case basis and are not automatically granted.
- 4. I confirm that I have been advised by the AIBC to seek independent legal advice regarding this Undertaking and Covenant and have had the opportunity to do so before signing. I have either obtained legal advice or freely chosen not to do so.
