Professional Governance Act Transition | Repealed and Replaced Documents

The AIBC transitioned to the *Professional Governance Act* (PGA) on February 10, 2023. Part of the legislative transition resulted in the repeal of several AIBC regulatory documents, as they became obsolete or replaced under the PGA, *Architects Regulation* or AIBC Bylaws.
